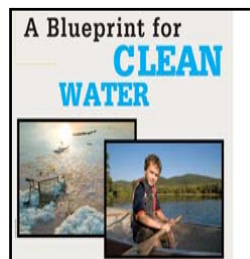

River Talk... By Christine Ellis, Waccamaw RIVERKEEPER®

A TOP TEN LIST FOR THE NEW ADMINISTRATION

In 2008, WATERKEEPER® ALLIANCE published its U.S. **Blueprint for Clean Water**, offering a new agenda for strengthening U.S. environmental protection to restore America’s ailing rivers, lakes, streams, wetlands and coastal waters. Unique in both its scope and depth, the Blueprint proposes a new way for the federal government to strengthen environmental protection in all areas relating to water and identifies the way forward for each of ten priorities:

- 1. Restore Protections** - An estimated 60% of our creeks, rivers, streams and tens of millions of acres of wetlands and other sensitive waterbodies have lost federal protection in the last few years.
- 2. Enforcement**- Clean Water Act enforcement programs at significantly harmed by shrinking funding and polluters are
- 3. Stormwater Runoff** - Runoff from highways, roads, side-infrastructure is the primary source of water pollution in
- 4. Sewage** - Sewage treatment and conveyance facilities are population served and fraught with leaks and overflows
- 5. Mercury** - Coal-fired power plants are the single largest spewing nearly 50 tons of this deadly poison into the air and
- 6. Diversions** - Shrinking water levels in rivers and lakes are ways are under growing pressure to provide many different tion, wastewater treatment, agricultural irrigation, recreation, hydropower and industrial uses.
- 7. Coal Mining** - Mountaintop coal mining is the scourge of communities in many rural areas with more than 400,000 acres of the world’s most productive and diverse temperate hardwood forests destroyed.
- 8. Agricultural Nonpoint Source Pollution** - Agricultural pollution is a major source of declining water quality in rivers and lakes, the second largest source of impairments to wetlands and a major contributor to the contamination of estuaries and groundwater.
- 9. Ocean Protection** - The continued ecological decline of our public seas represents a major threat to our economy, security and environment.
- 10. Environmental Justice** - Society’s wastes flow toward communities debilitated by high illiteracy, unemployment and low voter registration, causing pollution that has adverse effects on people’s health and is a violation of human rights.

A dream turns into a reality...

The Waccamaw River will have a Blue Trail!!!

Thanks to a generous grant from the Gaylord and Dorothy Donnelley Foundation, American Rivers, along with its partners, Winyah Rivers Foundation's Waccamaw RIVERKEEPER®, and the Pee Dee Land Trust, will begin work in Horry and Georgetown Counties to create a blue trail on the Waccamaw River.

Project Goals

The goals of this three year project are to improve recreation opportunities as well as public support for the river to assure it remains healthy. Collaboration with communities in Horry and Georgetown Counties to establish the Waccamaw River Blue Trail is essential to the project.

Blue trails, the water equivalent to hiking trails, help facilitate recreation in and along rivers and are used by paddlers, anglers, hikers, picnickers, and those seeking a little solitude. While the blue trail will improve recreational opportunities, it will also help to educate citizens, local governments and the elected officials about the importance of the river as a community asset, increase community involvement in the river, and support conservation.

This blue trail is part of a larger effort and it will serve as an innovative model for how to bring people back to their rivers through recreation and work to protect and restore these valuable assets.

The Partners

American Rivers:

The mission of American Rivers is to protect and restore America's rivers for the benefit of people, wildlife and nature. Founded in 1973, American Rivers' work is driven by a core conviction that a healthy river is one of a community's most valuable assets.

"A healthy Waccamaw River that provides the community benefits of clean and flowing water, recreation and nature-based tourism will depend on the protection of this incredible resource" said Gerrit Jobsis, American Rivers' Southeast Regional Director.

Pee Dee Land Trust:

The mission of Pee Dee Land Trust is to conserve the significant natural, agricultural, and historical resources of the Pee Dee Region of South Carolina through education and outreach, and primarily through voluntary land conservation projects. Created in 1999, the Pee Land Trust has almost doubled its territory for land conservation projects.

"This day in time, you can't just do nothing and expect natural areas to stay the same. As people look for more ways to protect the Waccamaw, PDLT can offer some of the tools that help take care of such a well-loved river" said Jennie Williamson, the Executive Director of the Pee Dee Land Trust.

Waccamaw RIVERKEEPER® Program of Winyah Rivers Foundation:

The mission of Winyah Rivers Foundation is to protect, preserve, monitor and revitalize the health of the lands and waters of the greater Winyah Bay watershed. Founded in 2001, the Foundation seeks to ensure that the land and water uses in the watershed support a high quality of life for all human and natural uses. The Foundation initially sought to ensure these protections in the Waccamaw River watershed and in 2002 sought licensing from the WATERKEEPER® ALLIANCE and hired the Waccamaw RIVERKEEPER® as a full-time, paid advocate for the ecological, social and economic health and integrity of the Waccamaw River watershed.

"The blue trail project will help us to engage local citizens in the stewardship of their watershed," said Waccamaw Riverkeeper, Christine Ellis, who serves as the local voice for the Waccamaw River. "This project is among our top priorities for the watershed because of the benefits for the community and for the long-term health of the river."

The partners are excited about the opportunity afforded us to promote land conservation and sustainable land uses, facilitate and promote community use and protections for the river, and foster stewardship of the Waccamaw River watershed.

Mitigation Monies Used to Conserve Land

In 2005, Central Electric Power Cooperative received approval from SC Office of Ocean and Coastal Resource Management to site a power line across the Black River in Georgetown County. On behalf of Winyah Rivers Foundation (WRF) and the Sierra Club, South Carolina Environmental Law Project filed an appeal and ultimately received a settlement of \$125,000 to be used for land protection in the area. WRF members Michael Hyrowski, Larry Fox and Christine Ellis and SCELPA's Amy Armstrong sat on the committee to identify areas of high conservation value worthy of protection and in late 2008 successfully identified a worthy land conservation project. Working with Maria Whitehead of The Nature Conservancy (TNC), we used these settlement funds to contribute to the Winyah Bay Drainage Protection Project. The Project, coordinated by TNC and including the Grissom Parkway Mitigation Fund, a WWF Foundation grant and private funds, endeavors to undertake landscape level protection of strategic tracts of freshwater, forested and estuarine wetlands, along with uplands threatened by development in the Black, Pee Dee and Waccamaw River corridors. Approximately 1660 acres of land, including five former industrial forest tracts, will be protected under this Project. The easement will be held by the Pee Dee Land Trust. WRF is appreciative of the efforts of the committee and all of the Project partners. This successful conclusion to the appeal and settlement will help to protect prime wildlife and natural resource habitat in perpetuity.

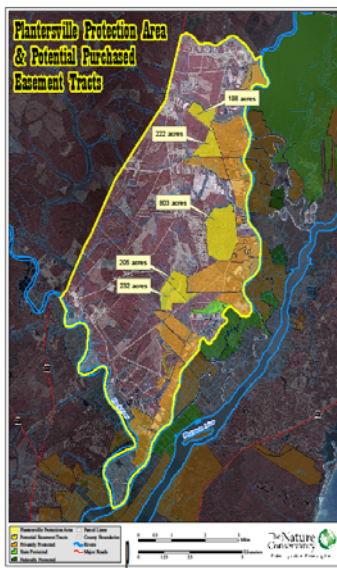
SPRING GARDENERS:

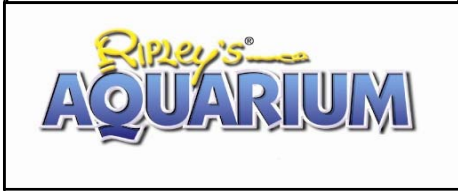

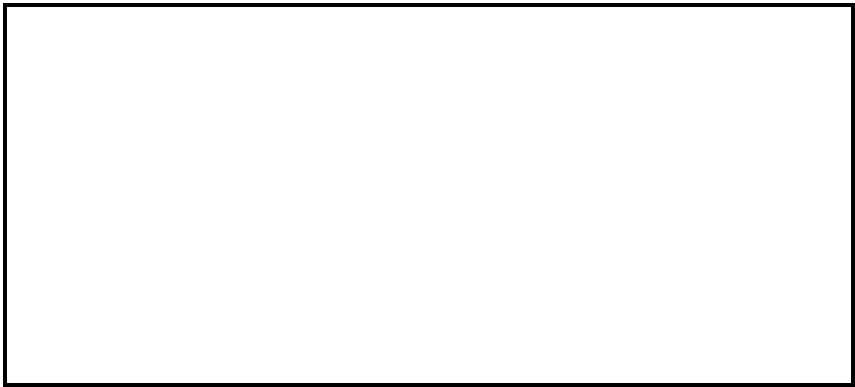
