WATERKEEPERS at the front line



As a member of WATERKEEPER® ALLIANCE, we are proud to be a family of nearly 200 Waterkeeper organizations on six continents defending their communities against anyone who threatens their right to clean water. Sadly, our own Congress appears to be threatening that right. Waterkeepers nationwide are concerned about current efforts to cut funding to clean water safeguards and key conservation programs. These cuts would mean more sewage and pollution in our waterways, less protected lands for wildlife and represent a serious threat to public health, our natural heritage and our ability to protect our public trust, our waterways and important conservation lands. Specifically in our area, cutting the Land & Water Conservation Fund will directly impact the Waccamaw National Wildlife Refuge, a protected area vital to maintaining clean water, preserving wildlife and providing a diverse coastal ecosystem.

We hope that you will agree that our natural resources, including clean water and healthy wildlife communities, are essential for the economic benefit of the Carolinas. The President, in his recently released America's Great Outdoors Report, proposed a budget for 2012 that reflects an investment in conservation programs that not only protect our natural heritage but that also generate jobs and boost local economies.

SPRING CLEANUPS BEGIN

Do you love your river? Do you hate the trash? Then join in on our cleanups.

Our spring cleanup season begins **March 26th** in Conway, hosted by the Rickenbakers (Rick was the 2006 Volunteer of the Year). Then, on **April 22nd** (yes, Earth Day!), we're going to target Crabtree Canal and Swamp in Conway with help from CCU's Eco-Reps and launch a program to educate local businesses on how to keep trash in its place. On **May 14th**, we'll move upstream to Longs and be hosted by the Stevens of Loris.

We're also partnering on the initiative, **Keep Horry County Beautiful**, a new chapter of Palmetto Pride, and will be helping with the County's litter index in March. KHCB's mission is "to inspire residents and visitors to value and protect the natural beauty of Horry County and to empower them to keep roadsides, riverways, open spaces and beaches clean and litter free."



AROUND THE GLOBE

Pamela Martin, associate professor of politics at Coastal Carolina University, spent time in Ecuador as a Fulbright Scholar conducting research on global and local dimensions of energy policy and conservation in the Amazon. She focused on Ecuador's decision to leave its largest oil reserve underground in Yasuni National Park, a UNESCO Man & Biosphere Reserve, in return for 50% of its value to be spent on conservation and alternative energy. Pam notes "Countries like Ecuador, poor in economic capital yet wealthy in terms of extreme biodiversity and natural resources, are not waiting for the world's leading nations to develop a climate change strategy that works for them."

SPOTLIGHT THE GREAT PEE DEE RIVER

The Great Pee Dee River basin encompasses 22 watersheds and 4,029 square miles, flowing across the Sandhills to the Coastal Plain and into the Coastal Zone region. Of the ~2.5 million acres, 33.4% is agricultural land, 25.7% is forested land, 27.9% is forested wetland, 6.3% is urban land, 2.7% is scrub/shrub land, 2.6% is water, 1.2% is non-forested wetland, and 0.2% is barren land. There are ~4,669 stream miles, 10,864 acres of lake waters, 17,676 acres of estuarine areas.

But, the waters of the Pee Dee are impaired for pollutants including Mercury which limit fish consumption. And, a 2009 USGS study identified widespread occurrence of inter-sex bass in the river.

The river is important for recreation and as a drinking water source. The lower river from Highway 378 to Winyah Bay is designated a Scenic River. The Great Pee Dee River is an important part of our natural heritage and deserves protection.

Waccamaw River Blue Trail*—Come paddle with us!

Project partners presented a session at the Waccamaw Conference themed "Protect Our Lands". Staci Williams, American Rivers, and Van Whitehead, Pee Dee Land Trust, were joined by Maria Whitehead of The Nature Conservancy to speak about our efforts to identify opportunities for land conservation within the Waccamaw watershed.

We continue to work on several tools to improve the trail experience, including identification of signage requirements in and along the river, the development of an online interpretive guide to natural, historic and cultural resources of importance and the development of a waterproof map for the trail.

Our call for the **Adopt a Landing Program** has been well received with several local groups interested in partnering. We're still working out the details but have some preliminary information available at our website. Thanks to those who have already expressed an interest!

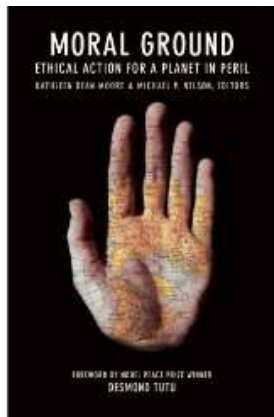
We applaud the President in his recently released report on America's Great Outdoors (AGO) Initiative for proposing to establish the AGO National Recreational Blueway Trails Initiative to designate community scale portions of rivers as recreational destinations that receive special attention for restoration and access.

Note: The SC project has spawned an effort in North Carolina to expand the Blue Trail upstream. The RIVERKEEPER® has been working with stakeholders in Brunswick and Columbus Counties to develop this concept and seek input from the community.

In Memory of...

Rachel Broadhurst—because of her love of the environment and her civic mindedness (fondly remembered by the Moliternos).

Emily Schultz, one of our founders, died Feb. 23 at her home in Myrtle Beach at the age of 88. She played a key role as chair of the Winyah Group of Sierra Club, when it joined with the Cape Fear, NC Group of Sierra in 1999 to form the Waccamaw River and Watershed Protection Project. She was the coordinator for the series of meetings that led to establishment of Winyah Rivers Foundation two years later. Her love of the local environment will be permanent in what is known as the Schultz Tract, a 192-acre portion of the Waccamaw River Heritage Preserve. The land, on the north end near the state line, was sold to the state trust in 1995 far below the market price and affords one of the few camping spots on the high ground as well as a public hunting area. A memorial service is planned for some time in April (by Zane Wilson).
