## Cove Swamp will be Protected!



Thanks to the efforts of many individuals and organizations, Cove Swamp, a 440 acre forested tract bordering Lake Waccamaw, will now be protected in perpetuity. The property owner, Riverstone Properties, LLC out of Richmond, VA, had been in negotiations with The Nature Conservancy of North Carolina to sell the property but hit a road-block when the price could not be agreed upon. Once negotiations ceased, Riverstone intimated that the property would be



harvested for its timber values. The Friends of the Green Swamp, the Friends of Lake Waccamaw State Park, other local residents and interested stakeholders raised concern and sought to address the shortfall in funds necessary for TNC to purchase the property. Several months later, thanks to all involved, TNC received the funds necessary to purchase the property and protect it. Contributions were received from over 100 people from and including the Town of Lake Waccamaw, 2 local businesses, Winyah Rivers Foundation and Friends of Sampson County Waterways. 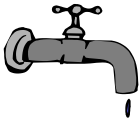

## FROM THE RIVER

Last issue I mentioned that the **RIVERKEEPER®** program is like being in the “preventative” health care business. I have had conversations with several health care professionals and they all seemed to agree that not enough is done to bring awareness to the public concerning the wellbeing of our WATER. They are concerned about storm water run-off, animal waste (pets, farms and wildlife). The increase in these problems along with dwindling water supplies should be of primary concern. The water supply is at risk if we don’t act NOW to inform everyone of the potential threat. Every decision we make has it consequences. What will be the consequence of not making the effort to protect the health of our rivers! The next time you turn the tap will it be clean and healthy water that comes out? We can only hope. If we are not vigilant, our access to a clean and healthy source of water could be in danger!

## RIVER TALK... by: Christine Ellis, Waccamaw RIVERKEEPER®

As a RIVERKEEPER®, my job is to educate and advocate for the protection of our local watersheds. One of the tools we use is the federal Clean Water Act (CWA), enacted in 1972 to clean up and protect our nation’s waters. The cornerstone of surface water quality protection in the US, the CWA employs both regulatory and non-regulatory tools to reduce pollutant discharges into our waterways. Its broader goal is to restore and maintain the chemical, physical, and biological integrity of the nation’s waters in order to support the protection and propagation of fish, shellfish, and wildlife, and recreation in and on the water.

For over three decades, the CWA afforded protections to waters of the US, including headwaters, wetlands and intermittent streams, all integral to the health of our water resources; however, two recent US Supreme Court cases (SWANCC, Solid Waste Agency of Northern Cook County v. Army Corps of Engineers, and Rapanos v United States) undermined these protections, leading to confusion about which waters are protected and stripping protections from our nation’s water resources.

In response, new protective legislation to stop these Clean Water Act rollbacks was introduced as the Clean Water Restoration Act and reintroduced in April 2009 by US Senator Russ Feingold. The CWRA seeks to remove the confusion created by the Supreme Court decisions and to restore protections to all waters of the US, the original intent of Congress when the CWA was enacted in 1972.

Water is interconnected, a dynamic resource that continuously cycles through our environment. Comprehensive federal legislation that provides for consistent protection of water resources nationwide is a necessity. It was seen as necessary in 1972 when the CWA was enacted and shall be so again under the CWRA.

Passing the Clean Water Restoration Act in 2009 will restore longstanding safeguards for America’s water resources and put us back on the path toward protecting all of our drinking water, lakes, rivers, streams and wetlands. *Without this legislation, America’s waters will remain at risk.*
